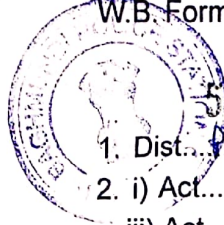

Sub: Lodging of F.I.R. against the culprits.

Sir,

I lodge this complain against my husband Priyaranjan Dutta, son of Sri Sibaram Dutta and the mother of Priyaranjan Dutta namely Smt. Mukta Dutta, my uncle-in-law Dinabandhu Dutta and his wife Reena Dutta all residents of Khatra, Pump More, Post Office and Police Station- Khatra, District- Bankura on the following facts:-

1. That my marriage with Priyaranjan Dutta was held and performed on 23.04.2017 after performing all religious rites, ceremonies and it was a negotiated marriage and my uncle-in-law and his wife took active part in negotiating the marriage.
2. That after marriage with all hopes I had been to my father-in-law's house with a high-dream but all my expectations became futile and I was subjected to torture both physically and mentally at the hands of the aforesaid persons. My husband is a moneyed man having petrol pump, brick kiln and other types of business and all the accused persons insisted me that at the time of marriage insufficient dowry was given and they insisted me to bring cash and kinds thereafter I intimated the said fact to my father. My father with a view to maintaining peace in our lives gave some money to my husband, but the demand of my husband and his mother was sky kissing & for these I was subjected to torture at their hands and I was compelled to do all heavy works and they treated me as maid servant. At the time of my

marriage my father gave sufficient ornaments utensils. However during my stay I became pregnant but my husband and his mother did not bother me and compelled me to do all house hold works.

3. That due to the torture, assault and due to heavy work my pregnancy was miscarriage. My husband after taking liquor used to assault me in the evening and it was his daily routine affair. My husband put burning cigarette on my body. I bore all those torture with a hope that due to passage of time the behaviour of my husband and his parents will change but due to passage of time such torture increased and it was an unbearable torture. My mother-in-law and my uncle-my-law and his wife provoked my husband to assault me and openly gave out that they will give marriage of Priyaranjan with an affluent lady. My parents and my younger brother on many occasions came to khatra and tried to pursue my husband and his inmates to behave properly but they were insulted. Due to heavy torture and ill-treatment I fell sick but my husband and his inmates did not make any arrangement for my treatment and ultimately my father took me to Baghmundi for treatment. After staying for some days at Baghmundi when I recovered to some extent my father took me to khatra but my husband and his mother again began to assault me and torture me to a great extent. Thereafter as I could not bear the said torture I intimated the said fact to my father.

4. That the financial condition of my father is very poor.

5. That on 27.03.2022 my brother Pradyut Khan took me to my matrimonial home and requested by husband his ^{Parents} presents to keep and maintain me. The mother and other inmates of my husband also abated the said commission of offence. On that day I spent a sleepless night in my matrimonial home. My husband caught hold my neck and

began to press me and said that he will finish my life and will tell the police that I have suicide . On the following day i.e. on 28.03.2022 I called my brother over my call phone and immediately came to Khatra and took me to my father's house . The husband and his mother kicked my abdomen and other parts of my body .

6. That on 03.04.2022 at about 9 pm my husband and some unknown person came near my father as house at Baghmundi in a Maruti van and called my father and my elder brother . Unknown persons covered their face by clothes . When my father and elder brother and myself came out from the house the said person threatened us with dire consequences . My husband who was on drunken mood openly stated that if Bristi dares to go to Khatra she will be murdered . The said person hurriedly left the place by abusing us .

7. That I am a destitute lady and neglected wife and due to such torture I have already decided to finish my life by committing suicide due to my misery .

Under such circumstances the undersigned begs to record this complain in First Information Report against the aforesaid persons for torture , both physically and mentally , ill-treatment , harassment and dowry demand .
