I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Suryanarayan Kumar, S/O- Late Purnashashi Kumar of village - Torang, P.O. – Dava Torang P.S- Bagmundi Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 11/04/2022 at about 03:15 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sajal Kumar Mahanty, Sr. O.E. 2. Subhasis Mahato, Sr. O.E. entered the premises of Sri Suryanarayan Kumar, S/O Late Purnashashi Kumar of village - Torang, P.O. - Dava Torang P.S- Bagmundi, Dist- Purulia and found Sri Suryanarayan Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Suryanarayan Kumar S/O- Late Purnashashi Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1.Sajal Kumar Mahanty, Sr.O.E. 2. Subhasis Mahato, Sr.O.E. The inspection team left the premises at 03:25 p.m. on 11/04/2022
