On 11/04/2022 at about 03:30 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sajal Kumar Mahanty, Sr. O.E. 2. Subhasis Mahato, Sr. O.E. entered the premises of Sri Tapananda Kumar, S/O Late Haradhan Kumar of village - Torang, P.O. - Dava Torang P.S- Bagmundi, Dist- Purulia and found Sri Tapananda Kumar was enjoying electricity unauthorisedly drawing power from the nearest L & MV line of WBSEEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Tapananda Kumar S/O- Late Haradhan Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1.Sajal Kumar Mahanty, Sr.O.E. 2. Subhasis Mahato, Sr.O.E. The inspection team left the premises at 03:40 p.m. on 11/04/2022
