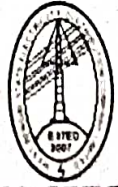

Dear Sir,

This is to inform you that today i.e 01.04.2022 at about 11.50Hrs, undersigned visited village Bansgarh, Balarampur on routine inspection where we observed that Sri Sukdev Mahanty, S/O-Lt. Sitaram Mahanty construct his second stored dwelling building in the above said location under Balarampur PS by negligently breaks, injures, throws down or damages our material connected with the supply of electricity of 11kv Barabazar-2 feeder, feed from Balarampur 33/11kv substation which may leads to total blackout of about 15nos village in the part of the Balarampur & Barabazar development block & may endangered the loss of life, violating the IE rule section no - 77,79 80 & 82.

In connection to the above it is to be mention here that M/s. H.N Yadav Construction (Prop-Sri Sreshnath Yadav of Alongodanga, Purulia) is our high tension line maintenance agency of Balarampur 33/11kv substation vide our Order no-5100649720 and as per accused declaration (copy enclosed) his workers are involved in his crime. Hence this matter to be considered in further enquiry.

Now, from the above facts it is clear that the accused is committed a crime which is punishable under section 139 & 140 of the Electricity Act 2003 read with up to date amendment.

Therefore, it is requested to take cognizance of the matter and taking lawful action against him/them by treating this written complain as FIR.
