Sir,

I, SI Sanjay Diger of Balarampur PS do hereby lodge complaint against unknown miscreant to the effect that on 02.04.2022 at about 19:45 hrs while I am performing mobile duty vide Balarampur PS GDE No- 70 dt- 02.04.2022 and CC No- 1328/2022 dt- 02.04.22, received a source information that an unknown miscreant is present back side of Dakbunglow unde^r Balarampur P.S with a firearm. Informed the fact to O/C Balarampur P.S and myself along with my accompanying force left for the spot. Having reached near the spot, kept our vehicle in a distance and we the Police party crawled towards the spot with my source and found that one person is sitting on rostrum of a big tree and one object is just right side of him on which that person was keeping his right hand. When we reached very close to him, hearing our footstep that person became alert and seeing us started to flee away. We chased him but he disappeared in the dark. Returning to the spot found one firearm like object. During thorough search with the help of Torch Light observed that the object is one Iron made Wooden butt improvised Fire Arms having length approx 22cm, in which written in the barrel Made in Japan. I tried to get public witness there but none could be availed on that place. So I seized that firearm with the help of my accompanying force and labeled also.

Therefore, I pray that a specific case may kindly be started against the unknown miscreant under section 25 Arms Act and for arranging its investigation.
