Respected Sir,

In producing here with the arrested accused person namely **Ajay Mahato (age-28 yrs approx) S/O-Niranjan Mahato of Vill. Golhura, P.S. Bandwan, Dist. Purulia** along with seized Foreign liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 01/04/22 at about 20:35 hrs received a credible source information over mobile, that one person is carrying Foreign liquor without any valid documents / license. Accordingly, myself along with force (1) C/725 Marzook Ahmed (2) C/672 Kausar Ali (3) C/726 Mehadi Hussain along with vide Bandwan PS CC No. 731/22, Dtd-01.04.2022 left for above noted place to work out the said source information. Then, at about 21:05 hrs we reached at Bandwan-Galudih main road near Ghatihuli mor and found the said person is Carrying Foreign liquor at an open public place at said road. So, with the help of accompanied force searched him thoroughly with proper decency and maintains all legal formalities and found that he was carrying foreign liquor. Being asked he failed to produce any valid license or permission from concern authority to carrying the following mention foreign liquor at that public place. Accordingly, He arrested above noted accd. person after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, he seized KINGFISHER STRONG, PREMINUM BEER-30 bottles, containing 650 ml. @ Rs. 120/- each. Thus, total quantity of foreign liquor-19 liters 500 ml. of Rs. 3600/-. One bottle of the each above mentioned items seized as sample file after preparing proper seizure list & labeling duly signed by the witnesses and accused person.

Under the above circumstances and fact, I therefore pray that a Cog. case may kindly be started **U/S-46A (a) (c) B.E. Act 1909** against the arrested accused person namely Ajay Mahato (age-28 yrs approx) S/O-Niranjan Mahato of Vill. Golhura, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
