Respected Sir,

I, S.I. Jol Kumar Mandy of Bandwan PS do hereby submitted complain against unknown miscreants to the effect that today i.e. on 04/04/22 at about 21:05 hrs, I received a credible source information that an unknown miscreant is present near Ashpara mor by the side of Bandwan-Katin road with a firearms with some ill motive. Accordingly, myself along with force (vide Bandwan PS C.C. No. 755/22, Dtd-04/04/22) left P.S. to workout said source information after obtain kind permission from O/C Bandwan P.S. Having reached near the spot, kept our vehicle in a distance and we the Police party crawled towards the spot as per source information. In the light of the running vehicle we found that, one person is standing at the back side of a big tree. When we reached very close to him, hearing our footstep, that person became alert and seeing us started to flee away. We chased him, but he disappeared in the dark. Thereafter, we returning to that spot, found one firearms is lying on the ground under the said tree which situated very close to Ashpara Mor. During thorough search with the help of torch light, observed that the firearms is Country made pistol (details are in seizure list). I tried to get public witness there, but none could be availed. So, I seized that firearms with the help of my accompanying force and labeled also.

Therefore, I pray, that a specific case may kindly be started against the unknown miscreant under 25 Arms Act. and for arranging its investigation.
