Respected Sir,

I, SI Anupam Garain of Bandwan PS do hereby lodge complaint against unknown miscreant to the effect that on 05.04.22 at about 21:55 hrs, received source information that an unknown miscreant is carrying firearms and ammunitions with a view to commit any crime near Ghatihuli Mor on Bandwan-Galudih main road. Informed the fact to O/C Bandwan PS and myself along with my accompanying force (vide Bandwan PS CC No 766/22, Dtd-05/04/22) left for the spot with my source. Having reached near the spot, when got down from our vehicle saw a person to flee away towards Galudih side. We chased him, but he disappeared in the dark and could not detain him. We saw falling of something from him on the road. During search with the help of torch light, observed that the object was a packet containing 02 rds. live 7.65" ammunitions. I tried to get public witness there, but none could be availed. So, I seized the ammunitions with the help of my accompanying force and labeled also.

Therefore, I pray, that a specific case may kindly be started against the unknown miscreant under 25 Arms Act and for arranging its investigation.
