Sir,

In producing herewith with the seizure list and the seized articles I.e.-

1. One improvised country made one Sutter pipe gun, length about 16 mm, butt about 7.5 mm (wooden), barrel 9.8 mm bore 1 cm marked as exhibit "A".
2. One round of 8 mm K.F cartridge, length about 6.5 mm marked as exhibit "B" (Loaded with exhibit "A").
3. One white colour plastic bag.
4. One black color plastic in which the arms and the ammunition was wrapped. (kept in the bag)

I SI Uttam Chatterjee of Barabazar PS, Dist- Purulia do hereby lodge complaint against the unknown miscreant to the effect that on 01.04.2022 vide GDE No-45 dt 01.04.2022 and C.C No-836/2022 after keeping the govt vehicle bearing Registration No-WB 26K 5475 from 19.45 hrs as per order of IC Barabazar PS myself along with, C/-1182 Santosh Mahato and C/-1494 Manas Mukherjee, and all on sudden seen the Police party one unknown person riding by motor cycle was coming towards Kukurchari morh from Jharkhand area threw a plastic wrapped with something and returned back then & there . After keeping proper guard, we assumed with suspected ground chased him but in vain. We carried with, investigation kit box, Laptop and other widgets, gala seal, candle, matches papers etc.

In the night hours the place was almost crowd less, very few curious person was on looking the matter but as soon we requested them to be the witness of the search, they denied to remain present as witness to avoid further hazards. On search in presence of accompanied forces and after opening the plastic found that one fire arms loaded with one round ammunition was wrapped in the bag. After unloading the arms taking measurement of the arms and ammunition as (i) length about 16 mm, butt about 7.5 mm (wooden), barrel 9.8 mm bore 1 cm (ii) length about 6.5 mm. I seized the same under proper seizure list and labelled in presence of the witnesses. Took the help of investigation kit box for this purpose. I also sealed the same at said place. The process of seizure took place in between 20.15 hrs and 20.45 hrs.

Held an enquiry in and around the P.O to collect any information about the culprits with intend to arrest him but no any fruitful result. Engaged source to trace out the culprits.

Then we left for Barabazar PS for starting a case and to take further actions as per provision of law. He was carrying a country made pipe gun and ammunition to sale/transfer for illegal purpose and for unlawful gain.

I came to PS. Prepared this letter of complaint and submitted it to I.C Barabazar through duty officer to start a case under proper section against the unknown miscreant and to arrange for its investigation.
