Sir,

In producing herewith with the seizure list and the seized articles i.e.-

1. Fully Iron made one improvised country made one Sutter pipe gun, length about 24 cm, butt about 7.5 cm (covered with wooden), barrel 14 cm bore 1 cm marked as exhibit "A".
2. One black color plastic in which the arms was wrapped. (kept Exhibit "A") as Exhibit-"B"
3. One nylon bag as Exhibit -"C" (Kept Exhibit "B")

I SI Lakshmi Kanta Pati of Barabazar PS, Dist- Purulia do hereby lodge complaint against the unknown miscreant to the effect that on 04.04.2022 vide GDE No-211 and C.C No-863/2022 dt. 04/04/2022 by govt vehicle bearing Registration No-WB 26K 5475 as per order of IC Barabazar PS myself along with, C/-111 Samulal Tudu and C/-2743 Soumen Sangiri, were performing mobile duty and when we reached on Berada- Laldih pitch road at about 18.25 hrs found one person coming towards Berda side by a motor cycle and seen the police party threw a bag near Berada community hall & returned back very quickly.

After keeping proper guard, we assumed with suspected ground chased him but in vain. We carried with, investigation kit box, Laptop and other widgets, gala seal, candle, matches papers etc.

In the night hours the place was almost crowd less, very few curious people was on looking the matter but as soon we requested them to be the witness of the search, they denied to remain present as witness to avoid further hazards. On search in presence of accompanied forces and after opening the plastic found that one fully iron made fire arms was wrapped by black colour plastic in the bag. After that taking measurement of the arms as (i) length about length about 24 cm, butt about 7.5 cm (covered with wooden), barrel 14 cm bore 1 cm. I seized the same under proper seizure list and labelled in presence of the witnesses. Took the help of investigation kit box for this purpose. I also sealed the same at said place. The process of seizure took place in between 18.45hrs and 19.35 hrs.

Held an enquiry in and around the P.O to collect any information about the culprits with intend to arrest him but no any fruitful result. Engaged source to trace out the culprits.

Then we left for Barabazar PS for starting a case and to take further actions as per provision of law. He was carrying a country made pipe gun and ammunition to sale/transfer for illegal purpose and for unlawful gain.

I came to PS. Prepared this letter of complaint and submitted it to I.C Barabazar through duty officer to start a case under proper section against the unknown miscreant and to arrange for its investigation.
