In producing herewith 02 (Two) arrested accused persons namely (i) Bimal Rajak (32 Yrs) S/o- Lt. Gangadhar Rajak & (ii) Hari Kumbhakar (30 Yrs) S/o- Guhiram Kumbhakar both of Vill- Berada, PS-Barabazar, Dist-Purulia along with seized articles- (i) One iron made BHOJALI length about 15 Inch (ii) One iron made BHOJALI length about 9 inch (iii) One live ammunition marked K.F 8mm (iv) One three cell torch light (v) 02 (Two) bamboo stick, length about 3.5 fit (vi) One iron made rod, length about 2.7 fit (vii) Country spirit bottle with plastic glass (viii) Approx half bundle Biri and one matches & (ix) One Aadhar Card having No- 2881 6118 7506 in the name of Nirmal Ch. Mahato.

I beg to lodge a complaint to the effect that duty on 10.04.2022 duty officer received a source information that some unknown miscreants are assembled behind the BTM College and preparing themselves to commit dacoity in Saraswati Petrol Pump nearby Namopara bypass under Barabazar PS. Duty officer informed the matter to I.C Barabazar PS. Accordingly, I.C Barabazar PS briefed us and directed us to work out the said source information with additional officers of night mobile duty to be tagged on the way. The fact noted in GD, this refers to Barabazar PS GDE No- 513 Dtd. 10.04.2022. Myself along with C/- 667 Sayed Julhar Ali, C/- 975 Ashoke Saharay, C/- 1182 Santosh Kumar Mahato, C/- 1474 Tushar Kanti Mandal & C/- 2567 Bubun Mahanty left PS to work out the information as per direction of I.C Barabazar PS. This refers to Barabazar PS GDE No- 515 Dtd. 10.04.2022 and C.C No-923/2022 Dtd. 10.04.2022. We carry sufficient light, kit box, papers, carbon gala, etc.

Myself along with force reached nearby Barabazar BTM College and stop the vehicle by the side of Road keeping distance approx 200 meters from BTM College. On the way at Sasankali Mandir Night mobile officer ASI Sadhan Ch. Danda and force tagged with us. After that, we started to proceed towards Nengsai River Ghat behind BTM College on foot. At about 00.45 hrs when we reached near that place, we found 05/06 persons sitting by the side of Negasai river under a bush at the back side of the BTM College, whispering to each other. Their voice was clearly audible to us due to late night & the place was a silent zone. They were planning to commit dacoity in the Saraswati Petrol Pump. After confirmation, we cordoned the area secretly and loudly disclosed our identity with a direction to surrender before us. But, all of them tried to run away seeing the Police party. However, we manage to apprehend 02 (two) out of them after a hot chase. I interrogate them thoroughly where they disclosed their identity (i) Bimal Rajak (32 Yrs) S/o- Lt. Gangadhar Rajak & (ii) Hari Kumbhakar (30 Yrs) S/o- Guhiram Kumbhakar both of Vill-Berada, PS- Barabazar, Dist- Purulia. On search, we recovered and seized above noted articles under proper seizure list & Labels duly signed by the witnesses and apprehended persons. I like to note here that due to odd hours of night no public witnesses were available at that time. The seizure was made between 01.15 hrs and 01.35 hrs.

During interrogation they disclosed that they along with (i) Kuriram Majhi S/o Baruni Majhi of Vill+PS- Boram, Dist- East Singhbhum, JKD (ii) Nirmal Ch. Mahato S/o- Kolebar Mahato of Vill- Oriya, PO- Dulmi, PS- Nimdih Dist- Saraikela Kharswona, JKD and 3 others being armed with deadly weapons were gathered and preparing themselves for committing dacoity in Saraswati Petrol Pump at Barabazar bypass road. Accordingly, I arrested them after maintaining all formalities regarding arrest. Informed them the grounds of arrest and informed relatives.

Hence, I do here by lodged complaint against (i) Bimal Rajak (32 Yrs) S/o- Lt. Gangadhar Rajak (ii) Hari Kumbhakar (30 Yrs) S/o- Guhiram Kumbhakar both of Vill- Berada, PS- Barabazar, Dist- Purulia (iii) Kuriram Majhi S/o Baruni Majhi of Vill+PS- Boram, Dist- East Singhbhum, JKD (iv) Nirmal Ch. Mahato S/o- Kolebar Mahato of Vill- Oriya, PO- Dulmi, PS- Nimdih Dist- Saraikela Kharswona, JKD and 3 others to start a specific case against them under proper section of law.
