I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that PRADIP MURMU (user) S/O Late PRADHAN MURMU VIII- FAGUDI, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- L4137841) From its incoming Service Cable through 02-Core PVC service cable and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

At About 01:20 P.M., entered into the premises of PRADIP MURMU (user) S/O Late PRADHAN MURMU VIII- FAGUDI, Dist- Purulia and inspected his premises at VIII- FAGUDI, P.S Barabazar, DIST- Purulia.

During inspection, it was found that PRADIP MURMU (user) S/O Late PRADHAN MURMU VIII- FAGUDI, P.S- Barabazar, Dist.- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- L4137841) From its incoming Service Cable through 02-Core PVC service cable in his premises at FAGUDI having connected load 0.352 KVA.

From the above he was using the following arrangements:

01. 03 nos Bulb (60 watts each)
02. 02 no of Fan(60 watts)

I seized the following articles from the said premises:

01. Pvc 02 core service cable with by-passing arrangement-04 feet(Approx)
02. Meter number L4137841(Landis)

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 01:30 P.M.

The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
