Sub: Complaint against Mohan Mahato (55 Yrs) S/o- Lt. Rabilochan Mahato of Village- Goddi, P.O- Puriyara PS- Barabazar, Dist- Purulia to start a specific case.

Sir,

In producing here with one Mohan Mahato (55 Yrs) S/o- Lt. Rabilochan Mahato of Village- Goddi, P.O- Puriyara PS- Barabazar, Dist- Purulia to start a specific case under arrest and seized articles (i) One Plastic Jarakin containing approx 09 (Nine) liters of I.D liquors (Cholai), (ii) 05 (Five) empty plastic glasses under proper seizure list as per enclosed seizure list and taken 500 ml ID Liquor (Cholai) seized as sample from Sl No. (i).

I, ASI Manas Kr. Pan of Barabazar PS do here by lodge this complaint against Mohan Mahato (55 Yrs) S/o- Lt. Rabilochan Mahato of Village- Goddi, P.O- Puriyara PS- Barabazar, Dist- Purulia that on 26.04.2022 during my mobile duty vide Barabazar PS GDE No- 1535 Dtd. 26.04.2022 received a source information that one person unauthorized selling I.D liquor (Cholai) at Village- Goddi in the house of the accused person under Barabazar PS, Dist- Purulia. I have been then verified the credibility of that information and as per direction of I.C Barabazar PS myself accompanied with ASI Partha Sarathi Bose and forces had been to Goddi village in the house of the accused person to work out the information. At about 19.05 hrs found one person was selling I.D liquor (Cholai). When we reached near the house of the accused person, then seeing the Police party, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking Plastic Jarakin containing approx 09 (Nine) liters of I.D liquors (Cholai) and selling from his dwelling house. I also found 05 (Five) empty plastic glasses on the floor of the house. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of I.D liquors. On being asked he confessed his guilt and stated that he selling the ID liquors (Cholai) with intent to sell to make own profit. He disclosed his identity as Mohan Mahato (55 Yrs) S/o- Lt. Rabilochan Mahato of Village- Goddi, P.O- Puriyara PS- Barabazar, Dist- Purulia. He also admitted that he had no license or any authorization to carrying and selling of ID Liquor. Accordingly, I seized the above noted article after preparing a proper seizure list and put label on the seized article in presence of witnesses and 500 ml of I.D liquor (Cholai) taken as sample from that seizure as sample which was also duly labeled and also took signature of the accompanying witnesses as well as accused person on seizure list and label also.

Thereafter, I secured arrest of the accused Mohan Mahato (55 Yrs) S/o- Lt. Rabilochan Mahato of Village- Goddi, P.O- Puriyara PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guide line. Informed him and his relatives regarding the ground of arrest. The arrest was made at 19.15 hrs on 26.04.2022.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered against said Mohan Mahato (55 Yrs) S/o- Lt. Rabilochan Mahato of Village- Goddi, P.O- Puriyara PS- Barabazar, Dist- Purulia and also for arranging for its investigation.
