Sir,

In producing herewith with the seizure list and the seized articles i.e.-

1. One improvised country made one Sutter pipe gun, length about approx 09 inch, barrel length approx 05 inch, Bore 1.5 cm. Marked as exhibit "A".
2. One round of 12 bore cartridge, length approx 06 cm, marked as exhibit "B"
3. One black color plastic bag in which the arms and the ammunition was wrapped.

I ASI Raju Mukherjee of Boro PS, Dist- Purulia do hereby lodge complaint against the unknown miscreant to the effect that on 02.04.2022 vide Boro PS GDE No-71 Dated 02.04.2022 and C.C No-882/2022 after keeping the govt vehicle bearing Registration No-WB 42 S / 4996 myself along with, C/-253 Arabinda Mallick and C/-1204 Bolzer Shaikh, were performing Evening Mobile duty and all on a sudden seen the Police party one unknown person left from Kultard Football Ground to Jharkhand area and threw a black colour plastic wrapped bag with something. After keeping proper guard, we assumed with suspected ground chased him but in vain. We carried with, investigation kit box, other widgets, gala seal, candle, matches papers etc.

In the night hours the place was crowd less, no person was there. We search the nearby area for local people as witness but found none. On search in presence of accompanied forces and after opening the plastic found that one fire arms and one round ammunition was wrapped in the bag. Took measurement of the arms and ammunition as (i) length about approx 09 inch, barrel length approx 05 inch, Bore 1.5 cm (ii) length about 06 cm. I seized the same under proper seizure list and labelled in presence of the witnesses. Took the help of investigation kit box for this purpose. I also sealed the same at said place. The process of seizure took place in between 21.45 hrs and 22.15 hrs.

Held an enquiry in and around the P.O to collect any information about the culprits with intend to arrest him but no fruitful result. Engaged source to trace out the culprits.

Then we left for Boro PS for starting a case and to take further actions as per provision of law. The unknown miscreant was carrying a country made pipe gun with ammunition to sale/transfer for illegal purpose and for unlawful gain.


I came to PS. Prepared this letter of complaint and submitted it to Boro P.S through duty officer to start a case under proper section against the unknown miscreant and to arrange for its investigation.


