Sir,

In producing herewith one arrested accused namely Sk Babu(32),s/o-Sk Ali Hussain of Purulia Katin Para under Purulia(T) PS, Dist-Purulia, A/P-Village-Hijuli, PS-Hura, Dist-Purulia with Arrest Memo, seizure list, other related papers and seized articles such as (1) one country made improvised single bore fire arms having length from Barrel to butt of 22 cm (approx) with wooden butt having length 9 cm (aprox), firing pin, trigger barrel having length 10.5 cm (aprox) (2) one 8 mm live ammunition having full length of 7.5 cm aprox under proper seizure list and being labeled properly, I beg to inform you that today (04.04.22) during my spl. anti crime mobile duty at Lalpur more under Hura PS area vide Hura PS CC No-1185 Dtd-04.04.2022 & GDE No- 163 Dtd-04.04.2022 at 22.35 hrs received a telephonic information from my reliable source that one person aged about 35 years was seen loitering near at Daldali petrol pump on Lalpur-Puncha road under Hura PS and a careful observation from the close point of view something like the butt of a small firearms was seen at his waist being kept supported with his pant and it was his firm belief that it was nothing but a fire arms . I asked him to keep eye upon the suspicious person and consulted with O/C Hura PS over telephone about this matter and as per his direction at 22.45 hrs, I along with C/1450-Uttam Mahapatra, C/838-Rakhal Ch Mahato both of Hura PS started for working out the information after briefing them properly about the gravity of the information and my plan to nab him. We reached at Daldali more at around 22.55 hrs and keeping the vehicle parked in a safe place we preceded to the spot on feet. On reaching there, my source identified the person by gesture from a distance and we apprehended one youth at 23.00 hrs and on asked he identified himself as namely Sk Babu(32),s/o-Sk Ali Hussain of Purulia Katin Para under Purulia(T) PS, Dist-Purulia, A/P-Village-Hijuli, PS-Hura, Dist-Purulia and I disclosed him about the information and on searching one iron made single bore country made fire arms having length of 22 cm (approx) with butt, barrel, firing pin, trigger etc has been found. The length of the barrel is 10.5 cm (approx) and was recovered from his exclusive possession and on opening the fire arms one live ammunition of 8 mm was recovered as being loaded in the fire arms. On asked he failed to produce any constitutional papers in support of possessing or keeping the fire arms. I seized the above narrated firearms and ammunition from his possession under proper seizure list and also labeled them separately in between 23.05 hrs & 23.25 hrs, but no public witness could be made available there on that time. After seizure I arrested him at 23.35 hrs observing all the formalities regarding arrest as his offense comes under the purview of Indian Arms Act.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
