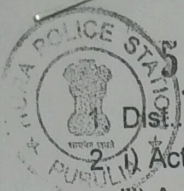

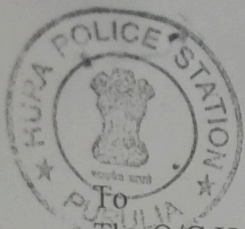

Sub: Request for lodging F.I.R. against the driver of offending vehicle


Sir

In producing herewith one arrested accused person namely Yogendra Yadav (23 yrs.) S/O- Gandhauri Yadav of Vill- Murumdag, PO-Dhotwa, PS – Itkhori, Dist – Chatra, state- Jharkhand 825408 along with one seized Vehicle (Tata Motors Ltd, Signa 4923S) having registration No NL01AD- 6519 loaded with iron ore and two(02) damaged guardrails, I beg to state that on 14.04.2022 I SI Gopal Bhattacharyya along with C/1052-Shyamlal Murmu, HG/1441-Sukumar Kalindi were engaged for day mobile duty at Bispuria road side vide Hura PS GDE No- 587 Dtd-14.04.2022 & Hura PS CC No- 1280 dtd-14.04.2022. At 12.15 hrs while we were at about 200 mtrs away from Pather sathi Naka point towards Bispuria side, we noticed that a Vehicle (TRAILER) coming from Hura side to Bispuria side with high speed and rash and negligent manner dashed first two guardrails placed properly on road in front of Pather sathi Hotel and then dashed the iron made traffic Police booth situated beside the left side of Hura- Bispuria road and tried to run away. But after a strong effort we could detain the offending vehicle and apprehend the alleged driver. We found that Traffic Police booth has been fully damaged and two guardrails were also damaged. After thorough interrogation he identified himself as noted above and the registration no-NL01AD/6519 loaded with iron ore. On being asked he was unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.


Accordingly I seized the vehicle having registration No- NL01AD- 6519, Engine No – 91C63777477 & Chassis No – MAT704131K3C08872 loaded with iron ore and two damaged guardrails with a view to start a specific case against him & offending vehicle. The whole process of seizure was completed in between 12.25 hrs and 12.45 hrs and after that I arrested him at 12.55 hrs.

Hence I pray that a specific case U/S- 279/427 IPC & section 3 of PDPP act 1984 may kindly be initiated against accused Yogendra Yadav (23 yrs.) S/O-Gandhauri Yadav of Vill- Murumdag, PO-Dhotwa, PS – Itkhori, Dist – Chatra, state- Jharkhand 825408 and offending vehicle and arrange its investigation.
