Sub: To start a specific case.

Sir,

I SI Asoke Kr. Sen of Jhalda PS, Dist-Purulia do hereby lodge a suomoto complain after arriving at PS that today 05.04.2022 Lalong with force was performing L/O duty at the Jhalda Municipality Gate as per the Police Arrangement vide Memo no 3917(50) dated 4.4.2022 of SP DIB Purulia in respect of the Memo no 754/SDO/JLD dated 29/03/2022 of SDO Jhalda in connection with the 1st meeting of the newly elected members is rescheduled on 05.04.2022 at 12:00 hrs at the meeting Hall of Jhalda Municipality with a view to elect the chairperson of board of Councilors of Jhalda Municipality vide Jhalda PS GDE No- 204 dtd- 05.04.2022 in consonance with Jhalda PS Spl CC No-42/2022 dtd-05.04.2022. In that respect, the proceeding of U/S 144 (2) Cr.P.C has been promulgated vide Misc Case No-383/22 dtd. 04/04/2022 and the announcement for that promulgation of 144(2) Cr.P.C was conducted yesterday in the Municipality area. Following this, the Executive Magistrates had been deployed to perform the magisterial duty to guide police for maintaining Law & Order. Police personnel were deployed accordingly to maintain the Law & Order as per Police Arrangement and to enforce the proceeding U/S 144(2) Cr.P.C. In course of the duty, I saw that a procession of about 200/250 people equipped with lathi, flag and festoons were coming from Birsamore Side under the leadership of Biplab Kayal, Pintu Chandra, Suman De, Baidyanath Kaibatya, and others all of Jhalda Town and they arrived at the police barricade at about 11:35 hrs and pushed police barricade as well as the detailed police personnel away. Subsequently, the unruly mob forcefully entered into the area identified under the promulgation of 144 (2) Cr.P.C. Consequently, the detailed police personnel repeatedly asked the members as well as the leaders of the unruly mob to abstain from such illegal act but none paid heed. As a result, some of the police personnel received injury. Thereafter, the unruly mob under the leadership of the above noted persons sat on the road in front of the Municipality Gate. I also found that the Ranchi - Jhalda road has been blocked by them after forming unlawful assembly. Subsequently I saw some of the members of that unruly mob threatened the drivers of the vehicle with dire consequences by lathi if they tried to move the vehicles. The vehicular traffic was totally disrupted and seized along the Purulia-Ranchi road. Latter they dispersed from there 12:15 hrs. Thereafter, the vehicular traffic movement became normal after our assiduous act. As the unruly mob obstructed and deter the public servant adamantly from the discharge of our public functions by using criminal force after showing disobedience knowing that there is the promulgation of 144(2)Cr.P.C, they committed offence U/S 143/186/283/353/506 IPC & 18 W.B Highway act 1964. Subsequently, I submitted suomoto complain against the them before your good self to start specific case.
