To The inspector – in- Charge Jhalda Police Station Purulia

Sir,

I ASI Dinabandhu Bauri Jhalda PS do hereby lodged the complaint against the following persons namely Biplab Kayal S/O Lt. Madhusudan Kayal of Jhalda Poddarpara, councilor of Ward No 9 and 100/150 members ofJhalda Arnnapurna Subarna Banik Committee. It is to mention here that today (11.04.2022) I along with force namely RM/1454 Anup Pradhan, RM/1519 Abhoy Biswakarma of EFR camp at Jhalda PS was performing the Day Patrolling duty as per my detailment vide Jhalda PS GDE No 458 dated 11.04.2022 & CC no 943 dated 11.04.2022 with the detailed vehicle bearing registration no WB56B 4919. During my mobile duty, I received information from local public that a procession was coming from Jhalda bus stand side by bursting fire crackers. As soon as, I along with force arrived at Rajib Chalk at about 12:30 hrs, I found that a procession was coming from Jhalda Bus stand side and I was informed by the local people that a procession of Jhalda Arnnapurna Subarna Banik Committee consisting of 100/150 members under the leadership of Biplab Kayal S/O Lt. Madhusudan Kayal of Jhalda Poddarpara, councilor of Ward No 9 was playing the big sound system and bursting numerous fire crackers. I asked the leader of the procession to produce any valid documents as well as to stop playing sound system and to stop bursting fire crackers but they did not pay any heed to police. As I along with force was little in numbers so I could not forcefully resist the procession. Consequently, I informed my superior. In the mean time, I saw that some of the members of that procession bursting the fire crackers indiscriminately while the procession was passing in front of the Jhalda Old PS Boundary and gate. Some of them were throwing the scintillating fire crackers into the boundary wall and towards the staying place of Civic volunteers juxtapose the Old PS gate knowing that Civic volunteers would have stayed there. I tried to stop them but the unruly mob of the procession including the leader pushed me and my force away and restrained us from doing any precautionary act. Thereafter the both Civic volunteers namely Abhoy Mahato and Sashadhar Mahato came out from the gate and asked them not to throw any scintillating fire

them away also. Consequently, the fire flared up in a jiff due to the dried leafs of Akashmoni tree as well as due to scorching heat. As a result the 45 no of motorcycles, 6 no of Cycles and one tractor which were seized previously in different different cases were burnt into the ashes. Thereafter the Jhalda Fire brigade was informed and they immediately responded at the spot. Subsequently, the assiduous work of the Fire Service and other police personnel, the blaze of the arson came under control at about 14.35 hrs.

As the unruly members of the procession conducting the procession without any valid permission under the leadership of Biplab Kayal obstructed the public servant in discharge of public functions after forming unlawful assembly and caused mischief by fire substance to destroy the human dwelling place as well as the public property and they also committed the subversive act over the public property, so they committed the offence U/S 143/186/436 of the IPC and read with section 4 of Prevention of Damage to Public Property Act 1984 and 9 of the West Bengal Maintenance of Public Order Act 1972 and 24/26 of the West Bengal Fire Service Act 1950 and 32 of the Police Act 1961

Ergo, I do hereby lodge the complain before you to initiate a specific case against Biplab Kayal S/O Lt. Madhusudan Kayal of Jhalda Poddarpara, councilor of Ward No 9 and 100/150 members of Jhalda Arnnapurna Subarna Banik Committee.
