Sir,

In producing here with 03 (three) arrested accused person namely 1) Laltu Lohar (30 yrs) S/O Lt. Boloram Lohar 2) Chaton Nayak (24 yrs) S/O Mangal Nayak and 3) Gokul Nayak (22 yrs) S/O Lakhikanta Nayak all of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia and along with 02 (two) seized Tractors- (i) One tractor having registration No-WB55B-0715 attached with sand loaded trolley (Approx 100 cft) and (ii) One tractor having registration No-WB55B-0802 attached with sand loaded trolley (Approx 100 cft). The fact in brief is that today (23.04.2022) I along with force namely i) C/1496-Subal Ch. Mahato, ii) C/1284-Pratapaditya Majhi, iii) NVE/779-Samir Mahato & iv) HG/1681-Manmotha Kumar was performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 1004 Dated- 23/04/2022 in consonance with Jhalda PS CC No- 1061/22 Dated- 23/04/2022 in PS area. During my duty I received credible source information that 02 (two) Tractors were lifting & carrying sand illegally and coming from Shyamnagar Ghat which is situated on Subarnarekha River at Jharkhand Purulia Border & proceeding towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at Gokulnagar More near Mahato Hotel to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the two tractors were proceeding towards Birsha More side. Consequently, we intercepted the said Tractors at Naka checking point at about 20:30 hrs and found that those vehicles as well as goods as identical as I received prior information. On being asked, the drivers of the both vehicles and one helper disclosed their names noted in the supra. I asked both the drivers of the vehicles to produce the valid documents in respect of the vehicles as well as the loaded sand. But the drivers of those said vehicles could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked both the drivers to produce the valid papers but they stated differently in different times. The incoherent statement of both the drivers purported to be a suspicious to us. It was ascertained that the drivers of both the tractors and one helper loaded the said sand in cahoots with the owners of the vehicles by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that they in cahoots with the owners of the vehicles procured the said sand from Subarnarekha River from Shyamnagar Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized both the tractors having registration No-WB55B-0715 attached with sand loaded trolley (Approx 100 cft) and (ii) registration No-WB55B-0802 attached with sand loaded trolley (Approx 100 cft). under proper seizure list in presence of available witnesses duly signed by them and also arrested the drivers and helper namely 1) Laltu Lohar (30 yrs) S/O Lt. Boloram Lohar 2) Chaton Nayak (24 yrs) S/O Mangal Nayak and 3) Gokul Nayak (22 yrs) S/O Lakhikanta Nayak all of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against them. Thereafter, I brought those said tractors to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the drivers and helper namely, 1) Laltu Lohar (30 yrs) S/O Lt. Boloram Lohar 2) Chaton Nayak (24 yrs) S/O Mangal Nayak and 3) Gokul Nayak (22 yrs) S/O Lakhikanta Nayak all of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia and the owners of both the vehicles as the committed offence U/S 379/411/414/120B of the IPC & 21 (4) Mines and Minerals (R&D) Act-1957.
