Sir.

I, SI Milon Manna along with force return to PS and brought under seizure 02 (two) seized Tractors- (i) One tractor attached with trolley having Registration No WB55B-4529 loaded with approx 100 cft. sand (ii) One tractor attached with trolley having Registration No WB55B-2878 loaded with approx 100 cft. sand. The fact in brief is that today (24.04.2022) I along with force namely i) C/2260 Pranab Kr. Dey ii) C/2131 Ashipon Dhal were performing special raid duty at Tulin OP area vide Tulin OP GDE No- 763 Dated- 24/04/2022 in consonance with Tulin OP CC No- 817/22 Dated- 24/04/2022. During my special raid duty I received a credible source information that two Tractors was lifting & carrying sand illegally and coming from Bondih Ghat which is situated on Subarnarekha River at Jharkhand Purulia Border & coming towards Tulin. Subsequently, I informed you and as per your order, I placed Naka at Magha bridge to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the two tractors were proceeding towards Magha bridge. Consequently, we intercepted the said Tractors at Naka checking point at about 09:35 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police, 02 (two) drivers of Tractors fled away leaving the Tractors on road before Naka checking point. We tried to apprehend them but failed. We waited for reasonable time but none came to spot. It was ascertained that the driver of the tractors loaded the said sand in cahoots with the owner of the vehicles by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasonable to belief that they in cahoots with the owners of the vehicle procured the said sand from Subarnarekha River at Bondih Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle (i) One tractor attached with trolley having Registration No WB55B-4529 loaded with approx 100 cft. sand (ii) One tractor attached with trolley having Registration No WB55B-2878 loaded with approx 100 cft. sand under proper seizure list in presence of witnesses duly signed by them. Thereafter, I brought the said tractor to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the Owner & driver of the said vehicles and others as they committed offence U/S 379/411/414/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957
