Sir,

In producing herewith one improvised .12 bore pipe gun, with butt, barrel, firing pin, trigger etc. with proper seizure list. I would like to inform you that today (02.04.22) at about 19.05 hrs while myself along with 1. C/ 1189 -Swapan Gorai, 2. C/ 2928 - Fatik Majhi, 3. Jc/1401 - Irfan Ansary & 4. Jc/1505 - Bipadatan Seth along with Govt. Vehicle No- WB-07J/0511, were engaged in anti crime Special mobile duty at Baglata IC area under Joypur PS (this refers Baglata IC GDE No- 50, Dated-02.04.22 & CC No- 548/22, Dated-02.04.22), at that time at about 20.15 hrs I received an information from my secrete source that one Eklash Chowdhury @ Chhutu @ Bhutchhua (30) S/o-Tahit Chowdhury at Karkara, PS-Joypur, Dist-Purulia was seen loitering at the Karkar village area with a fire arms having in his possession. Accordingly, I inform to my I/C over cell phone regarding this information and as per order of IC Joypur PS myself along with my accompanied forces had been to the Karkara village and held raid into the house of house of Eklash Chowdhury @ Chhutu @ Bhutchhua but seeing police persons he escaped away from his house and we unable to detained him, accordingly we searched into his house maintaining all formalities of search and found one improvised .12 bore pipe gun with butt, barrel, firing pin, trigger etc. which was kept into a Tin-box of his house, then all articles taken into my custody after preparing proper seizure duly signed by the Police witnesses as there was no available any willing public witnesses due to night hours.

One improvised .12 bore pipe gun with butt, barrel, firing pin, trigger etc.

Under above circumstances, I, therefore, pray that a case U/S -35 of Arms Act 1959 may kindly be initiated against accused Eklash Chowdhury @ Chhutu @ Bhutchhua (30) S/o-Tahit Chowdhury at Karkara, PS-Joypur, Dist-Purulia.
