Sir,

In producing herewith 02 (two) round .303 live ammunition under proper seizure list. I would like to inform you that today (04.04.22) at about 15:35 hrs I, SI Mahadeb Rana along with force JC/-1498 Amit Sha NVF/-803 Ankur Ch Mahato were engaged in anti crime Special mobile duty at Joypur PS area vide Joypur PS GDE No- 163 & CC No- 1499/22, Dated-04.04.2022, at that time at about 19.45 hrs I received an information from my secrete source that one Batom Mudi of Narayanpur was loitering with arms & ammunition near Narayanpur more. Accordingly inform to my I/C regarding this information and as per order of IC Joypur PS myself along with my accompanied forces had been to the Narayanpur village and held raid into the house of Batom Mudi @Biren @ Singh @ Bottle but seeing police persons he escaped away from his house and we unable to detained him, we searched his house maintaining all formalities of search and found 02 (two) round .303 live ammunition which was kept canceled in a plastic carry bag hanging at the wall. Then all articles taken into my custody after preparing proper seizure list duly signed by the Police witnesses as there was no availability of any willing public witnesses. On enquiry it revealed that on Batom Mudi @Biren @ Singh @ Bottle, (35) S/O- Late Bidhan @ Nemai Mudi, Vill- Narayanpur, P.S. – Joypur, Dist-Purulia is the owner of the house and possessing fire ammunition without any valid documents.

Seized article:

- (1) 02 (two) round .303 live ammunition.
- (2) 01 (one) plastic carry bag.

Under above circumstances, I, therefore, pray that a case U/S -35 of Arms Act 1959 may kindly be initiated against accused Batom Mudi @Biren @ Singh @ Bottle, (35) S/O- Late Bidhan @ Nemai Mudi, Vill- Narayanpur, P.S. – Joypur, Dist-Purulia.
