Sub: Prayer for starting a specific case against one Nepal Mahato (27 Yrs) S/o- Radhanath Mahato of Vill-Marlong PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No- JH09V/7613).

Respected Sir,

With due respect I SI Manas Kr. Panda, beg to submit before you that on 15/04/2022 at about 14:55 hrs while myself along with C/-1234 Mantulal Mandal, C/-516 Chandra Sekhar Mahato & C/-1378 Prabir Kr Mishra were performing Special Drive (MV Checking) duty vide Joypur PS CC No-1623/22 Dated-15/04/2022 at Kathaltard Naka point on Purulia Bokaro Road (NH-32). I found one Motor Cycle was coming from Bokaro side towards Purulia with **Driving Dangerously**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Kathaltard Naka point. On interrogation he made incoherent statement at different time. He disclosed his identity as Nepal Mahato (27 Yrs) S/o- Radhanath Mahato of Vill-Marlong PS-Kotshila, Dist-Purulia. On being asked he failed to produce the driving license and other valid documents of Motor Cycle.

Hence he violated the provision of Section 279 IPC & R/W Section-184/181 MV Act. So I seized the Motor Cycle having Regd. No- JH09V/7613 at 15:05 hrs to 15:15 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Nepal Mahato (27 Yrs) S/o- Radhanath Mahato of Vill-Marlong PS-Kotshila, Dist-Purulia at 15:20 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailable hence accused rider namely Nepal Mahato was released on bail.

So I pray specific case may kindly be registered against the accused namely Nepal Mahato (27 Yrs) S/o- Radhanath Mahato of Vill-Marlong PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No- JH09V/7613) for committing offence U/S-279 IPC & R/W Section-184/181 MV. Act.
