Sub: Prayer for starting a specific case against one Barun Gope (24 Yrs) S/o- Sudhir Gope of Vill-Mohanpur PS-Chandankiyari, Dist-Bokaro State-Jharkhand (Motor Cycle Rider having Regd. No- JH09AU-8935).

Respected Sir,

With due respect I ASI Swapan Mandal, beg to submit before you that on 15/04/2022 at about 16:55 hrs while myself along with force were performing Special Drive (MV Checking) duty vide Joypur PS CC No-1629/22 Dated-15/04/2022 at Joypur Parichay Bhavan, College More point on Purulia Ranchi Road (SH-4A). I found one Motor Cycle was coming from Purulia side towards Kotshila side with driving at excessive speed. Police personnel, present their in proper Police uniform raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rush and negligently driving the Motor Cycle which may cause accident to the road user any time. After long chase we can able to apprehend him at Joypur College More. On interrogation he made incoherent statement at different time. He disclosed his identity as Barun Gope (24 Yrs) S/o- Sudhir Gope of Vill-Mohanpur PS-Chandankiyari, Dist-Bokaro State-Jharkhand. On being asked he failed to produce any valid documents of the said Motor Cycle.

Hence he violated the provision of Section 279 IPC & R/W Section-112/183(i) MV Act. So I seized the Motor Cycle having Regd. No- JH09AU-8935 at 17:05 hrs to 17:20 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Barun Gope (24 Yrs) S/o- Sudhir Gope of Vill-Mohanpur PS-Chandankiyari, Dist-Bokaro at 17:25 hrs avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bail-able hence accused rider namely Barun Gope was released on bail after furnishing proper bail bond.

So I pray before you that a specific case may kindly be registered against the accused namely Barun Gope (24 Yrs) S/o- Sudhir Gope of Vill-Mohanpur PS-Chandankiyari, Dist-Bokaro State-Jharkhand (Motor Cycle Rider having Regd. No- JH09AU-8935) for committing offence U/S-279 IPC & R/W Section-112/183(i) MV Act.
