Sub: Prayer for starting a specific case against one Kishalay Mahato (20 Yrs) S/o- Nirupada Mahato of Vill-Hetbatri PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No- JH09AT/0966 Black-Silver STR Hero).

Respected Sir,

With due respect I SI Mahadeb Rana, beg to submit before you that on 16/04/2022 at about 15:15 hrs while myself along with C/-1334 Jagannath Mandal, C/-857 Chepulal Murmu were performing Special Drive (MV Checking) duty vide Joypur PS CC No-1633/22 Dated-16/04/2022 at Kathaltard Naka point on Purulia Bokaro Road (NH-32). I found one Motor Cycle was coming from Purulia side towards Bokaro with **Driving Dangerously**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Kathaltard Naka point. On interrogation he made incoherent statement at different time. He disclosed his identity as Kishalay Mahato (20 Yrs) S/o- Nirupada Mahato of Vill-Hetbatri PS-Kotshila, Dist-Purulia. On being asked he failed to produce any other valid documents of Motor Cycle.

Hence he violated the provision of Section 279 IPC & R/W Section-184 MV Act. So I seized the Motor Cycle having Regd. No- JH09AT/0966 Black-Silver STR Hero at 15:25 hrs to 15:40 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Kishalay Mahato (20 Yrs) S/o- Nirupada Mahato of Vill-Hetbatri PS-Kotshila, Dist-Purulia at 15:45 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailble hence accused rider namely Kishalay Mahato was released on bail.

So I pray specific case may kindly be registered against the accused namely Kishalay Mahato (20 Yrs) S/o- Nirupada Mahato of Vill-Hetbatri PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No- JH09AT/0966 Black-Silver STR Hero) for committing offence U/S-279 IPC & R/W Section-184 MV. Act.
