Respected Sir.

In producing herewith seized 01 (one) DI 550 ACE Blue Colour Tractor bearing Registration No-JH02AA-0758 loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (24/04/2022) I ASI Swapan Mandal along with force 1) JC/-1489 Amit Sao 2) NVF/-1021 Bablu Mahato both of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-1746/22 Date-24/04/2022. During my mobile duty at about 11:45 hrs received a credible source information that one tractor loaded with sand is coming from Uparkahan side, I along with force reached at Palanja more under Joypur PS and found the DI 550 ACE Blue Colour Tractor bearing Registration No-JH02AA-0758 loaded with sand (100 CFT approx). On seeing the Police party at Palanja more under Joypur PS, the driver of the said tractor fled away leaving the tractor standing beside the village road. We rushed to the tractor and searched the said tractor and found that the tractor loaded with sand and also searched surrounding the P.O but I did not trace out the driver / owner of the said tractor. Hence I seized the tractor bearing Registration No- JH02AA-0758 loaded with sand (100 CFT approx) under proper seizure list in between 12:55 hrs and 13:25 hrs in presence of available witnesses and I brought the said Tractor to Joypur P.S. As such there is every reason to believe that the driver and owner of the said Tractor were lifting and transporting sand illegally from Kangasabati river bed near Kahan Ghat violating the provision of Mines and Minerals (R&D) Act-1957.

So the owner and driver of said tractor are liable for offence punishable U/S-379/411/414/120B IPC & R/W 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against driver & owner of the tractor bearing Registration No- JH02AA-0758 may kindly be started and arrange for its investigation.
