Sub: To lodge FIR against owner and driver of 02 (Two) tractor i.e. (1) Mahindra B 275 DI having Registration No WB55/7358 along with trolley (Without number plate) loaded with approx 100 CFT Sand and (2) Mahindra B 275 DI having Registration No WB81/0959 along with trolley (Without number plate) loaded with approx 100 CFT Sand.

In producing herewith, 02 (Two) tractor i.e. (1) Mahindra B 275 DI having Registration No WB55/7358 along with trolley (Without number plate) loaded with approx 100 CFT Sand and (2) Mahindra B 275 DI having Registration No WB81/0959 along with trolley (Without number plate) loaded with approx 100 CFT Sand.

The nub of the fact in a nutshell is that today on 27.04.2022 at 08.35 hrs. I SI Jagannath Saha of Kashipur PS along with (i) C/689 Prabhas Ch Mahato and (ii) C/2987 Gurudas Malla both of Kashipur PS, Dist - Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 1107 Dtd - 27.04.2022 and C.C No. 1243/22 Dtd. 27.04.2022. During my mobile duty, I received a tip off at 11.45 hrs. that some persons were loading two tractors with sand from the river bed of Darkeswar River near Sutabai village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolleys of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Darkeswar River and fled away from the spot. We rushed to the Tractors and detained the said tractors. We searched the said tractors and found that the tractors are loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractors. I searched the vehicles if any valid documents are available regarding said loaded sand but found nothing. Hence, I seized the above noted tractors along with trolleys loaded with sand as noted above and brought the said seized articles to Kashipur PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid document in support of carrying sand.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors along with the trolleys for investigation.
