In producing herewith arrested accused person namely Pradip Kumar Majhi (28 Yrs) S/o- Manoranjan Majhi of Vill- Sanjra, PS- Kamalpur, Dist- East Singhbhum, Jharkhand. along with one seized Hero HF Deluxe, RBK colour 100 CC Motor Cycle bearing Registration No- JH 05CG-6205 and Eng. No- HA11ENHGM04560 & Chassis No- MBLHAR20XHGM05061.

I beg to report that today myself along with C/-195 Santosh Kr. Sing Sardar, NVF- 129 Mahanta Murmu and HG- 1933 Lakhiandar Mura all are of Kenda PS were performing day mobile duty at Darodih Morh under Kenda PS area vide Kenda PS C.C No-500/22 dtd. 24.04.2022 and Kenda PS GDE No-778 dtd- 24.04.2022 at about 11.55 hrs, I found one motor Cycle bearing Registration No- JH 05CG-6205 coming from Taltal Hat side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated Sec. 279 IPC and I also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be start against accused Pradip Kumar Majhi (28 Yrs) S/o- Manoranjan Majhi of Vill- Sanjra, PS- Kamalpur, Dist- East Singhbhum, Jharkhand.
