I beg to report that today myself along with C/1130 Asik Ansari and C/1137 Sridam Bauri both of Kenda PS were performing Spl. mobile duty at Kenda Thana Morh under Kenda PS area vide Kenda PS C.C No-501/22 dtd. 24.04.2022 and Kenda PS GDE No-781 dtd-24.04.2022 at about 12:35 hrs, I found one motor Cycle bearing Registration No- JH 05N-7464 coming from Kenda village side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him.
