Sir,

In producing herewith the accused person namely Santa Majhi (22 Yrs.), S/o- Lt. Nagen Majhi of Vill- Mahespur, PS- Kenda, Dist- Purulia along with seized article i.e. one Red colour Mahindra B275 DI TU MKM DLX tractor having Engine No- RMC2EAN2529, Chassis No – MBNABAEXKMRC06550 attached with Trolley loaded with sand approx. 100 cft .

The fact of the case in brief is that on 24/04/2022 I along with C/-195 Santosh Kr. Sing Sardar and NVF- 129 Mahanta Murmu both of Kenda PS were performing Spl. mobile duty. During mobile duty on 24/04/2022 at about 15.05 hrs. when we reached at Kuruktopa more found that the above noted tractor was coming from Kuruktopa College side under Kenda PS. On seeing the Police party driver of the said vehicle stopped his tractor in a distance and he tried to fled away after keeping the tractor near at Kuruktopa more but we manage to detain the driver of the said tractor. On demand the driver of the said tractor failed to produce any valid documents in respect of the said tractor and loaded sand. It is ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized one Red colour Mahindra B275 DI TU MKM DLX tractor having Engine No- RMC2EAN2529, Chassis No –MBNABAEXKMRC06550 attached with Trolley loaded with sand approx. 100 cft. under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver of the said tractor after preparing memo of arrest duly signed by the accused driver. I also informed him regarding ground of arrest and arranged to inform his relatives. Thereafter arrange driver from my source and brought the tractor at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the seized tractor having Engine No- RMC2EAN2529, Chassis No – MBNABAEXKMRC06550 attached with Trolley loaded with sand approx. 100 cft.
