In producing here with the accused person namely Makhan Kumar (33) s/o Gurupada Kumar of vill.-Chekya, PS-Kotshila, Dist-Purulia, brought under arrest along with seized articles as per seizure list i.e. one improvised country made fire arms (Iron made) length in total 11.9 inch (Approx) (Butt - 3.3 inch, Body - 2.2 inch & Barrel- 6.4 inch) having wooden butt wrapped with black tape, body, barrel, trigger, firing pin etc and 01 (One) round 8 mm live ammunition marked as 'KF" which has been seized from the exclusive possession of said Makhan Kumar do hereby lodged a written complaint against the above noted arrested accused person to the effect that on 01.04.2022 at 20.05 hrs while myself along with C/982 Shyamal Kr. Rajwar, C/292 Krittibas Mahato & C/332 Ashok Kr. Kandu (Kotshila PS GDE No. 30 dated 01/04/2022 & CC No. 755/22) all of Kotshila PS, Dist.- Purulia were engaged in special evening mobile duty near Lupundih village at Sapai River Bridge on Lupungdih-Mohanpur village road and found the above noted person was coming from Mohanpur village Side via Lupungdih-Mohanpur village road towards Lupungdih village by foot and on seeing the Police party he tried to fled away. Immediately my team chased him and apprehended him at Sapai River Bridge near Lupungdih village. I asked him that why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made fire arm loaded with one round live ammunition which was kept in left side of the waist concealed under the shirt of Makhan Kumar. On demand he was unable to produce any valid documents /license in respect of keeping such arms & ammunitions, neither he can gave any satisfactory explanation in respect of carrying such arms ammunitions. It appeared he possessed those either to sell or to commit any crime. I unload the ammunition from the said improvised pipe gun after taking all precaution and seized the said arms and ammunitions with proper seizure list also the seized arms and ammunitions packed, sealed and labeled in presence of police witnesses since none found there available to witness. The seizure was made in between 21.25 hrs and 21.55 hrs. Hence I arrested him at 22:05 hrs as he has committed an offence which is punishable U/S 25/27 of The Arms Act 1959.

Hence I pray to start specific case against arrested accused person namely Makhan Kumar (33) s/o Gurupada Kumar of vill.-Chekya, PS-Kotshila, Dist-Purulia U/S 25/27 Arms Act.
