In producing here with the accused person namely Debasish @ Suraj Kumar (28 yrs) s/o Lt. Krishna Kumar of vill- Belyadih, PS-Kotshila, Dist-Purulia, brought under arrest along with seized articles as per seizure list i.e. one improvised country made double barrel fire arms (Iron made) length in total 12 inch (Approx) (Butt - 4 inch, Body - 2.9 inch & Barrel- 5.1 inch) having wooden butt, body, double barrel, double trigger, double firing pin etc and 01 (One) round .303 ammunition which has been seized from the exclusive possession of said Debasish @ Suraj Kumar do hereby lodged a written complaint against the above noted arrested accused person to the effect that on 04.04.2022 at 20.15 hrs while myself along with C/1543 Prabir Mandal, C/633 Dasarath Sing Mura & C/983 Radhakanta Kisku (Kotshila PS GDE No. 143 dated 04/04/2022 & CC No. 775/22) all of Kotshila PS, Dist.- Purulia were engaged in special evening mobile duty near Khairi more and found the above noted person was coming from Pandra village Side via Pandra-Khairi-Barahankal-Talli Centre village road by foot and on seeing the Police party he tried to fled away. Immediately my team chased him and apprehended him at Khairi more near Khairi village. I asked him that why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made fire arms loaded with one round live ammunition which was kept in left side of the waist concealed under the shirt of Debasish @ Suraj Kumar. On demand he was unable to produce any valid documents /license in respect of keeping such arms & ammunitions, neither he can gave any satisfactory explanation in respect of carrying such arms ammunitions. It appeared he possessed those either to sell or to commit any crime. I unload the ammunition from the said improvised fire arms after taking all precaution and seized the said arms and ammunitions with proper seizure list also the seized arms and ammunitions packed, sealed and labeled in presence of police witnesses since none found there available to witness. The seizure was made in between 20.55 hrs and 21.25 hrs. Hence I arrested him at 21.35 hrs as he has committed an offence which is punishable U/S 25/27 of The Arms Act 1959.

Hence I pray to start specific case against arrested accused person namely Debasish @ Suraj Kumar (28 yrs) s/o Lt. Krishna Kumar of vill- Belyadih, PS-Kotshila, Dist-Purulia U/S 25/27 Arms Act.
