Sir,

I, ASI Sambal Kr Singh of Manbazar PS do hereby lodge complaint against unknown miscreant to the effect that on 03/04/22 at about 20:45 hrs in course of my mobile duty, received source information that an unknown miscreant is carrying firearm and ammunition with a view to commit any crime near Dakdenya Kuman bridge adjacent area. Informed the fact to O/C Manbazar PS and myself along with my accompanying force (vide Manbazar PS CC No 758/22) left for the Spot with my source. Having reached near the spot, when got down from our vehicle saw a person to flee away towards Khanduana side. We chased him, but he disappeared in the dark and could not detain him. We saw falling of something from him on the road. During search with the help of torch light, observed that the object was a packet containing 01 live '32' ammunition. I tried to get public witness there, but none could be availed. So, I seized the ammunition with the help of my accompanying force and labeled also.

Therefore, I pray, that a specific case may kindly be started against the unknown miscreant under 25 Arms Act and for arranging its investigation.
