




> The above-named Complainant begs to state as follows: ..



1.---That te complainant and the present accused persons are residents of village Udaipur, P.S.Manbazar, Dist.Purulia.

3.---That the complainant had a she goat. on 18-03-2022 at about 6 P.M. the said she goat went out from the house of the complainant, When the said goat reached the near the house of accused No.1 Birbal Kisku. Accused No.1 to 4 seeing the she goat they all making criminal conspiracy with each other and they mixed poison with Boiled Rice for eating the said she goat. The said goat eat the Boiled Rice Mixx mixed with poison. Due to the eating of boiled rice mixed with the poison, the said she goad immediately died. Then accused persons No.1 to 4 taken away the said dead goat in their house and there after they all cut the meat of the said goat. Present witnesses saw the occurrence, present complainant search the said goat but it was not trace out the complainant after few hours, he came to learned that accd persons No.1 to 4 killed the goat and eat the meat ax of the goat. There after complainant went to the house of accused persons and asked them regarding has goat, But



But they threatened to kill complainant and his family members.

4.——That there after complainant informed the above incident to the local police of Manbazar P.S. on 19-03-2022. But the Manbazar P.S. has not started any police case against the accused persons. There after complainant informed the aforesaid incidence to the S.P. Purulia, still the police of Manbazar P.S. are quite mum and has not started any police case.

The accused persons are very dangerous, desperate type of men.

They have no regard upon law and order. The accused persons

No.1 to 4 are still threatening to kill the complainant. Hence the complainant is bound to filed the present Misc. Petition for proper relief.
