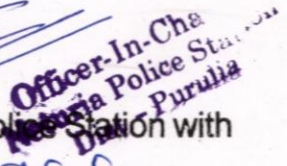

Sub: Prayer for initiating a cognizable case.


Sir,

In producing herewith one arrested accused namely Jishu Banerjee (33) S/O- Mahima Ranjan Banerjee of Vill-Andal Gram Misra Para, PO-Andalgram, PS-Andal, Dist-Paschim Burdwan along with one fire arms and one round of ammunition (Seizure list enclosed). I do hereby lodge a complaint against the above noted arrested accused to the effect that today (01.04.2022) at about 22:35 hrs during Naka checking duty at Dishergarh Ghat vide Neturia PS GDE No- 37 Date: 01.04.2022, we found that he is moving suspiciously there. On being asked about his suspicious movement he tried to flee away from there. However we managed to apprehend him, searched him and found one iron made wooden butt improvised fire arms (length approx 25 cm) loaded with 01 round of 08 MM KF live ammunition in a plastic packet from his exclusive possession. Being asked to produce any valid document in support to possess the arms and ammunition, he failed to produce any valid documents for his possession or give any satisfactory answers. I unloaded the ammunition from fire arms and seized the arms and ammunition after preparing proper seizure list duly signed by him and witnesses. The arms & ammunition were properly labeled. I arrested the above noted person after preparing arrest Memo.


As he violated the provision of Indian Arms Act, hence he is liable for prosecution under the arms act.

So, I pray a cognizable case may kindly be initiated against Jishu Banerjee (33) S/O- Mahima Ranjan Banerjee of Vill-Andal Gram, Misra Para, PO-Andalgram, PS-Andal, Dist-Paschim Burdwan under proper section of law.
