Sub: Prayer for initiating a cognizable case.

Sir,

In producing herewith one arrested accused namely Bhima Nunia (35) S/O- Lt. Chandu Nunia of Chinakuri Chhai Dhowra 04 No, PS-Kulti, Dist-Paschim Burdwan along with one fire arms and one round of ammunition (Seizure list enclosed). I do hereby lodge a complaint against the above noted arrested accused to the effect that today (04.04.2022) at about 19:15 hrs during my mobile duty at Dishergarh Ghat along with C/1361 Munshi Kamal Hossain and NVF/578 Niranjana Hembram vide Neturia PS GDE No- 161 Date: 04.04.2022 & CC No-1143/22 Dt. 04.04.2022, we found that the above noted accused person was moving suspiciously there. On being asked about his suspicious movement he tried to flee away from there. However we managed to apprehend him, searched him and found one iron made wooden butt improvised fire arms (length approx 25 cm) loaded with 01 round of 7.7 MM live ammunition from his exclusive possession which was kept conceal at his left side of waist. Being asked to produce any valid document in support to possess the arms and ammunition, he failed to produce any valid documents for his possession or give any satisfactory answers. I unloaded the ammunition from fire arms and seized the arms and ammunition after preparing proper seizure list duly signed by him and witnesses. The arms & ammunition were properly labeled. I arrested the above noted accused person after preparing arrest Memo.

As he violated the provision of Indian Arms Act, hence he is liable for prosecution under the arms act.

So, I pray a cognizable case may kindly be initiated against Bhima Nunia (35) S/O- Lt. Chandu Nunia of Chinakuri Chhai Dhowra 04 No, PS-Kulti, Dist-Paschim Burdwan under proper section of law.
