In producing herewith one arrested accused namely Bhola Nunia (24) S/O- Lt. Shiba Nunia of Chinakuri Chhai Dhowra 4 No., PS-Kulti, Dist-Paschim Burdwan with one semi automatic country made improvised pistol (iron made) approx 15 cm in length of barrel and approx 11 cm butt with one magazine, barrel, trigger, firing pin, hammer etc. along with 01 round live cartridge on which "7.65" and "KF" is stamped and one Bajaj Pulsar Motorcycle having registration No- WB 38AD/5946 to the effect that today on 04.04.2022 at 20:45 hrs while I, ASI Bachchu Ghosh along with force C/1550 Bharat Ghosh, C/1319 Soumen Koley and C/1302 Radhagobinda Dhibar were performing evening mobile vide Neturia PS GDE No- 181 & CC No- 1149/22 Dt. 04.04.2022 that time received a credible source information that one person is coming from Chirkunda side to Neturia PS area with an ill motive for committing any serious crime. Accordingly, I informed the matter to you and as per your kind order myself along with force who were engaged in evening mobile duty accompanied with me left for Maheshnadi Check Post to work out the information. After reaching at Maheshnadi Check Post at about 21:05 hrs, started Naka checking there. After some time we found that one person is coming from Chirkunda side (Jharkhand) by riding on a motorcycle and seeing the police party he tried to flee away from there and after a hot chase we managed to apprehend him. On being asked he disclosed his identity as noted above. Searched the above noted person very carefully in presence of witnesses and recovered one semi automatic country made improvised pistol (iron made) approx 15 cm in length of barrel and approx 11 cm butt with one magazine, barrel, trigger, firing pin, hammer etc. along with 01 round live cartridge on which "7.65" and "KF" is stamped from his exclusive possession, which was concealed in his waist and on being asked he stated incoherent statement in respect of his presence at the area at that time. There was every reasonable believe that the accused had come down in the area with a view to commit crime by using the illegal fire arms. On demand, he failed to produce any valid documents/ license in respect of the said arms & ammunitions and the M/C. Accordingly, I seized and labeled one semi automatic country made improvised pistol (Iron made) with 01 round live cartridge marked as "7.65" and "KF" and one Bajaj Pulsar M/C having registration no- WB 38AD/5946 from his possession under proper seizure list duly signed by the witnesses. During search and seizure I have tried to procure public witnesses to put down signature in the seizure list but the time was late night so no any person available there and arrested the above noted accused person at 21:45 hrs after observing all the guidelines of Hon'ble Apex Court of India, Hon'ble High Court Calcutta, N.H.R.C & W.B.H.R.C.

As he violated the provision of Indian Arms Act, hence he is liable for prosecution under the arms act.

So, I pray a cognizable case may kindly be initiated against Bhola Nunia (24) S/O- Lt. Shiba Nunia of Chinakuri Chhai Dhowra 4 No., PS-Kulti, Dist-Paschim Burdwan under proper section of law.
