Dear Sir,

On dated 07.04.2022 as per the report received from the meter reader, it was found that the energy meter bearing Sl No: B5155071 was missing from the premises of Sri Bipin Maji S/O-Sri Naran Maji ,existing consumer of Saltore Customer Care Center, WBSEDCL vide Consumer Id: 202778021 unauthorizedly and illegally beyond the knowledge of Saltore Customer Care Center.

During inspection on dated 07.04.2022 ^{at about 2:00 PM. Date: 07/04/22} and after scrutiny of office records by undersigned ,it has been found that the last spot reading was taken on 02/12/2021 and After that in the next billing cycle ,meter reader visited the place the meter is missing from the consumer's premises unauthorizedly.

Due to this office was unable to raise necessary energy bill for this consumer resulting blockage of Govt. revenue.

The above phenomenon is a cognizable offence under section 136 (1) (a) of the Indian Electricity Act 2003 duly amended on 2007.

The undersigned worried about that type of activities, it may not only the case of such type activities but also may found more cases in future.
