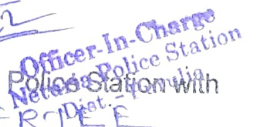

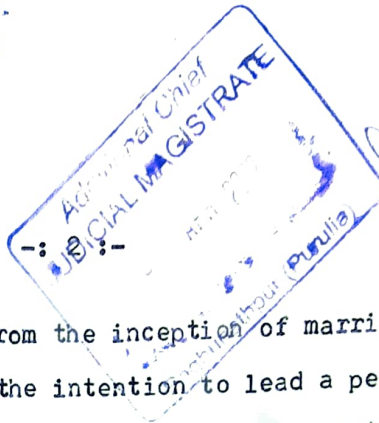
The humble petition on behalf of the above named

2. That after marriage the accused No.3 came to her matrimonia
house at Village Nabagram P.S. Neturia, Dist. Puruliya and
started living as the wife of the son of the Complainant and
due to the wedlock there is one son ~~and~~ named Avhra Khawas,
aged about 6th years.

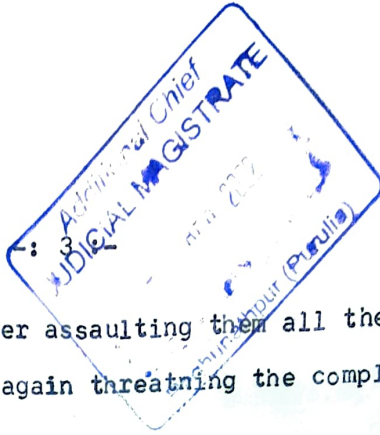

- 3) That right from the inception of marriage the accused No.03 never had the intention to lead a peaceful married life in her matrimonial house she frequently took up quarrels with her husband and other family members and she never bothered ~~xxx~~ to carryout her matrimonial duties.
- 4) That time and again the accused No.3 always left her matrimonial house without informing her husband and returned only after much persuasion from her husband and in-laws.
- 5) That lastly ^{.. 10.02.2020} ~~07.10.2020~~ she left her matrimonial house and again ~~xxx~~ went to her father's house and refused to return back despite several efforts of reconciliation.
- 6) That in the meantime the accused No.3, has filed a false criminal case against her husband and father-in-law U/s. 498A which has been registered as Andal P.S. case No.240/2021 on 08/09/2021 and presently the Complainant and his son are on Court bail.
- 7) That the complainant and his son kept on trying their best to persuade the accused No.3 to return back to her matrimonial house.
- 8) That on 08/03/2021 the above named accused person along- with two unknown persons came to the house of the Complainant for settlement of the dispute. But instead of settlement of the dispute they started the negotiation using abusive language against the Complainant and his son. And when the son of the Complainant raised objection at that point of time the accused No.1, and the unknown persons all of a sudden started assaulting the Complainant and his son.

9. That after assaulting them all the accused persons went away once again threatening the complainant dire consequences.
10. That the Complainant reported the matter to the duty officer at Neturia P.S. on the same day but no action was taken against the accused.
11. That thereafter the Complainant informed the matter to S.P.Purulia, through speed post on 30/03/2022 but till date the accused persons are roaming freely and time and again they are threatening the Complainant if he da ed to file anycase against them.
12. That there is every chance that the accused persons may again assault the complainant and his son or may again file false case/cases against them.

It is therefore prayed that your Honour may be pleased to send this petition to O/C.Neturia P.S. with a direction to treat it as F.I.R. U/s.156(3) Cr.P.C. and take appropriate legal action against the accused persons for the ends of justice.
