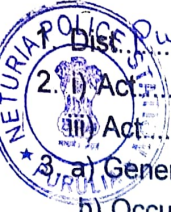

Sub : Prayer for treating the instant complaint as FIR

Sir,

With due respect I, the 1st Party member lodge this complaint to you against the accused 2nd Party member on the following grounds that the 2nd Party member sold me 73 decimals of Land in respect of the following schedule of Land on 29.07.1994 through Registered Deed of Sale.

Land Schedule

District : Purulia, Police Station : Neturia, Mouza : Nowada, J.L No. : 108, Plot No. : 125,
Sabek Plot No. : 125, Classification of Land : BaidArea 73 Decimals

That after purchase the said Plot of Land I applied for Mutation of the said Plot of Land in my favour before the BL & LRO, Neturia on 02.02.2022. I visited the Office of the BL & LRO, Neturia, Dist : Purulia to enquire about the facts of my application for Mutation, when I came to learn from the BL & LRO, Neturia that on the relevant date of registration i.e on 29.07.1994 the accused 2nd Party Member was owner of only 19 decimals of Land in the aforesaid Plot of Land and not 73 decimals of Land. The sisters of aforesaid Shambhu Mandal are the owners of the rest 54 decimals of Land. Therefore my name can be mutated only in respect of 19 decimals of Land and not 73 decimals of Land.

That I paid full consideration money to the Shambhu Mandal in respect of 73 decimals of Land whereas records reveals that he is owner of only 19 decimals of Land.

That he was cheated me knowing fully were that he is owner of only 19 decimals of Land in the aforesaid Land Schedule. It is also clear that he is party of a criminal conspiracy and has committed the aforesaid offence knowing fully well to cheat me and as a result I have sustained heavy financial loss and I can not get mutated my name to the entire 73 decimals of Land as described herein before.

Hence it is prayed before you to treat this complaint as an FIR against the accused 2nd Party member and book him under the relevant Sections of Indian Penal Code and other offences as per Law and initiate investigation and arrest him for cheating me and practicing fraud upon me. The photocopy of concerned Sale Deed dated 29.07.1994 is annexed herewith for your taking necessary action.

And for this act of kindness your petitioner shall ever pray.
