In producing herewith one arrested accused person namely Sk. Palhu @ Sk Salamat (45yrs) S/o Lt. Sk. Rustam Vill - Sankra B, PS- Para, Dist- Purulia under arrest with one country made improvised one shotter pipe gun having with iron butt, body barrel, trigger, hammer, firing pin etc, loaded with 01 (One) round .303 live cartridge under proper seizure list.

I would like to inform you that today (05.04.2022) in course of my Evening mobile duty vide GDE No- 207 and C.C No. 778/22 Dt 05.04.22 received telephonic information from my source at 22.15 hrs that one person was loitering Arjun Bagan under Para PS in a suspicious manner believed to have a fire arms in his possession. Accordingly I brought to notice before my O/C and the matter has been diarized by Duty Officer vide Para PS GDE No. 220 Dt- 05.04.2022 and as per his direction myself along with (1)C/1407 Susanta Goswami, (2) C/561 Dhananjoy Mudi, & (3) NVF- 822 Mangal Mahato of Para PS left with Govt. vehicle to work out the information.

Myself along with force reached nearby Arjun Bagan under Para PS with a distance and keep the vehicle and move towards the spot by feet. When we reached to the spot at about 22.25 hrs we found one person wearing with Red colour T-shirt was moving suspiciously and seeing us he was trying to escape from the place. But we managed to apprehend him and asked him in which purpose he was moving here and there at Arjun Bagan, he failed to give any satisfactory reply about his presence. On being asked he disclosed his identity as noted above but he failed to produce any valid identity in favour of him. In course of searching his body along with his wearing apparels one shotter pipe gun having with iron butt, body barrel, trigger, hammer, firing pin etc, loaded with 01 (One) round .303 live cartridge recovered from his exclusive possession. On being asked he failed to produce any valid documents in respect of said fire arms and ammunition.

Accordingly I seized the said recovered one shotter pipe gun having with iron butt, body barrel, trigger, hammer, firing pin etc, loaded with 01 (One) round .303 live cartridge under proper seizure list duly signed by him and Police witnesses. It is to be noted that during seizure no public witness could be turned up before me. I also arrested him after maintaining all formalities regarding his arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid arrestee under proper section of law.
