Sub- Lodging Of FIR against Shri Swapan Murmu, S/O- LT Balak Murmu, of Village - Mohuda, PO- Rukni, PS-Para, Dist- Purulia, for theft of electricity u/s 135(1)(a) of The electricity Act 2003 (Amendment 2007).

Dear Sir,

In producing here-with the following article 1. One Single core PVC Cable of approximate length 15 (Fifteen) feet with hooking arrangements, 1 number Bulb, 1 Switch Board seized under proper seizure list, duly signed by available witnesses I, Mr. **Debabrata Das (27 yrs)**, S/O- Late Belyanath Das, Assistant Engineer (E) & Station Manager, Dubrapara Customer Care Centre, WBSIEDCL, Para, Purulia do hereby lodge complaint against Name – **Shri Swapan Murmu, S/O- LT Balak Murmu** of Village – Mohuda, PO-Rukni, PS-Para, Dist-Purulia, to the effect that **today (ie on 12/04/2022)** at about **12:55 pm** acting on a tip – off, myself accompanied by Sri. Nimai Chandra Mahato, S/O- Adalot Mahato, (TSH), Sri Salim Ansary, S/O- Mogbul Anasy, (TSH) of Dubrapara CCC, WBSIEDCL went to the village Mohuda to work out on one source information. Around **12:55pm** of the said date we reached at the village Mohuda and inspected the electric lines in the commercial premise of the occupier Swapan Murmu and during inspection at about **12:55 pm** the user Swapan Murmu, found stealing electricity dishonestly at his occupied commercial premise by direct hooking from nearest LTOH line of WBSIEDCL and has caused financial loss to WBSIEDCL. The load is assessed as **2 KW** during preparing inspection report at the spot. There is also a previous dispute case on the same plot in the name of one his siblings Shri Krishan Murmu.

Thus the user cum occupier Shri Swapan Murmu, S/O- LT Balak Murmu, has violated the provision of **section 135(1)(a) The Electricity Act 2003 (Amendment 2007)**.

Hence I seized the above noted article under proper seizure list duly signed by available witnesses following disconnection of the unauthorized electric lines by removing the hooking devices and producing before you with a request to initiate a cause u/s 135(1)(a) of The Electricity Act 2003 (Amendment 2007) against Shri Swapan Murmu, S/O- LT Balak Murmu of village – Mohuda, PO – Rukni, PS-Para, Purulia, and arrange for its investigation. It is to be mentioned Shri Swapan Murmu, S/O- LT Balak Murmu were present there but **he refused to sign** as accused in the seizure list and inspection report. It is also to be mentioned that we disconnected the unauthorized connection at that premise and left the premise at about **01:15 pm** on the same day.
