Sri Tarashankar Banerjee while working as GDS Branch Postmaster, Nadiha BO in connivance with his son Sri Sanjib Banerjee committed permanent as well as temporary misappropriation of Govt. money from the following enclosed (Enclosed in annexure A and modus operandi in annexure B) Sukanya Samridhi account causing the loss of Govt. money.

Total permanent loss unearthed till dated is Rs 50000 /- (Rs Fifty Thousand) only and Past Work verification is going on and there is chance that the amount of fraud will increase.

So, cognizance of the case may be taken, FIR may kindly be lodged and investigation into the case may kindly be conducted at the earliest with intimation of development of the case to this office.
