In producing herewith (1) one country made improvised single barrel fire arms(Revolver) having length of 10 Inches (approx) with wooden butt, firing pin, tigger, body, butt length approx 3 inches and iron body length (approx) 4 inches, Barrel length (approx) 3 inches (2) 03 (three) Pcs empty wine bottles marked as Dilkhus (3) 04 (four) Pcs white colour plastic glasses (4) 01 (one) burning candle (5) 01 (One) Match box (6) some ends of Biri under proper seizure list duly signed by the witnesses I would like to inform you that today (01.04.22) at about 19.05 hrs while myself along with (1)C/617 Mrityunjoy Sahana (2) C/1228 Babulal Hansda (3) CD/ 1022- Satyanarayan Gorai along with Govt. vehicle No- WB-42S/1505 were engaged in anti crime Special mobile duty at Puncha PS area at that time at about 20.35 hrs I received an information from my secrete source that some unknown persons were assembled at Dhumfela Sonajhuri Jungle under Puncha PS (Puncha Hura boarder ) Dist-Purulia accordingly I inform to my O/C over cell phone regarding this information. Accordingly as per order of O/C Puncha PS myself along with my accompanied forces had been to the spot. When we reached approx 500 mtrs away from Dhumfela Sonajhuri Jungle approx 300 mtr south side of Tusugoria Baragram road near culvert at that time they smelt Police party and fled away from the said spot. After reached the spot at 20.55 hrs we started searching the spot meticulously with the help of our torch light and (1) one country made improvised single barrel fire arms(Revolver) having length of 10 Inches (approx) with wooden butt, firing pin, tigger, body, butt length approx 3 inches and iron body length (approx) 4 inches, Barrel length (approx) 3 inches (2) 03 (three) Pcs empty wine bottles marked as Dilkhus (3) 04 (four) Pcs white colour plastic glasses (4) 01 (one) burning candle (5) 01 (One) Match box (6) some ends of Biri and all articles taken into my custody after preparing proper seizure duly signed by the Police witnesses as there was no available any public witnesses duty to night hours. During my preliminary enquiry it seems that unknown persons assembled there for committing any cog offence and they spend their time by dirking wine and keeping their Fire Arms beside them to insufficient light and darkness of the said Sonajhuri Jungle so we were unable to arrest them as well as identified them after making all efforts from our ends. Therefore I seized (1) one country made improvised single barrel fire arms(Revolver) having length of 10 Inches (approx) with wooden butt, firing pin, tigger, body, butt length approx 3 inches and iron body length (approx) 4 inches, Barrel length (approx) 3 inches (2) 03 (three) Pcs empty wine bottles marked as Dilkhus (3) 04 (four) Pcs white colour plastic glasses (4) 01 (one) burning candle (5) 01 (One) Match box (6) some ends of Biri under proper seizure list and label. The above fact reflects that the said unknown persons were assembled there for committing any cog offence.

Under the above fact and circumstances I therefore lodge this written complaint as suo-moto against those unknown persons for taking necessary further steps under proper section of law
