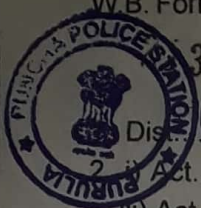





Respected Sir,

Today (11/04/2022) during my day mobile duty at 07.55 hrs after being informed by duty officer of Pancha PS regarding road blocked at Junurbari More on Tusugoria-Baragram road and the road was obstructed by some villagers of Junurbari and other villages over the issue of demand of newly set up of one Sub health centre at Junurbari, under the leadership of Tanmay Mahapatra S/O-Lt Danesh Mahapatra of vill-Baroghutu PS-Pancha Dist-Purulia regarding their illegal activities. Immediately after receiving the information myself along with force (i) C/1147 Bappaditya Nandi (ii) C/1260 Santosh Saren , (iii) LC/354 Kalyani Tudu, all of Pancha PS vide C.C. No- 718/22 and GDE No -529, Dt. 11.04.22 rushed to the spot at about 08.15 hrs and found that the road has been blocked by the rabble of (i) Tanmay Mahapatra, S/O- Lt. Danesh Mahapatra of vill-Baroghutu PO-Gholkurh (ii) Mrityunjay Murmu, S/O- Gobinda Murmu of vill-Junurbari PO-Gopalpur (iii) Rabi Saren, S/O- Lt Suku Saren of vill-Junurbari (iv) Sulekha Murmu, W/O- Bholanath Murmu of vill-Junurbari (v) Janaki Kisku, W/O- Lt. Jyotilal Kisku of vill-Junurbari (vi) Shyamal Murmu, S/O- Lt Suku Murmu of vill-Dhuliabaid PO-Gopalpur, all of PS-Pancha, Dist- Purulia and 15-20 others. After forming unlawful assembly subsequently vehicular traffic was totally disrupted and seized along the Tusugoria-Baragram road. I requested the above noted leaders to withdraw the blocked but they paid no heed to my words. Despite of all, I persuaded further and tried to convince the agitators that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied my proposal and deter my duty. I along with force started to disperse them form the road but the road blockers obstructed us adamantly from the discharge of their public functions. After the prolonged discussion the mob withdrew the blocked at 09:55 hrs. Thereafter, the vehicular traffic movement became normal after our assiduous act. As the above noted alleged persons along with 15-20 others committed offence u/s 188/186/283/34 IPC under the leadership of Tanmay Mahapatra. So a specific case may kindly be initiated against them and arranged for its investigation.
