Sir,

In producing herewith the arrested accused person namely Swapan Sahis (38) S/O Late Gunadhar Sahis of Vill- Belut, Po- Natherdanga, Ps- Indpur, Dist-Bankura along with all connected papers.

I beg to submit that on 18/04/2022 at about 10:15 I ASI Anupam Chand along with C/617 Mrityunjoy Sahana and J/C -1434 Rafik Ansary all of Puncha PS Dist- Purulia were performing surprise naka checking on Dhadki- Bankura road near Simakanali under Puncha PS, and found a motorcycle bearing no.-WB68L/3842 was coming in rash and negligent manner without wearing Helmet from Belut side side, Bankura boarder. We tried to stop the said motorcycle to check the valid documents regarding the said motorcycle but the above noted accd person did not pay any heed to our words and crossed us at near Simalkanali, towards Poradih side. After a while the said motorcycle along with the said rider returned back to the same way and after crossing us he stopped the motorcycle a few distance form us and used filthy languages as "আয় বোকাচোদারা পারবিতো আমাকে ধরে দেখা , বেধড়ক মারবো শালাদের কে " . At that time c/617 Mrityunjoy Sahana went there to stop him, suddenly he slapped to the said constable and started fist and blows and said constable fell down there. Beside this the barriers which are placed on road is also damaged by that person as he threw the barriers. On that moment I and JC 1434 RafiK Ansary went to the spot to rescue him, but above noted accused person become furious and again started slapping to said Junior constable and assaulted him with fist and blows as a result constable C/617 Mrityunjoy Sahana and JC 1434 Rafik Ansary sustained injury on their persons. When we tried to detain him but he try to fled away by leaving his motorcycle at the spot. Somehow after hot chase, we able to apprehended him, when he flying from us, he fell down and received light injury as abrasion on his waist. Accordingly I seized the motorcycle bearing no.- WB68L/3842 from the possession of accused namely Swapan Sahis (38) S/O Late Gunadhar Sahis of Vill- Belut , Po- Natherdanga ,PS- Indpur , Dist-Bankura and two broken barriers are seized from the PO under proper seizure list duly signed by available witnesses and arrested the above noted accd person at 10.55 hrs after issuing check list and brought him to PS after medical checkup of arrested accused person as well as injured police personals.

Under such situation I pray that a specific case may kindly started U/S 186/332/353/506 IPC read with sec 3 PDPP Act against the accd. person Swapan Sahis (38) S/O Late Gunadhar Sahis of Vill-Belut, Po-Natherdanga, PS-Indpur, Dist-Bankura.
