Sir,

In producing herewith the accd. person namely **Jabir Ansary (25yrs) S/O Jalal Ansary of Vill-Chaluniya, PS- Para, Dist- Purulia** under proper memo of arrest along with related documents. The following seized articles (i) One improvised country made iron made fire arms having barrel, butt, trigger and firing pin having a length of 8.3 inch (approx.) (ii) One live cartridge ammunition of length 3 inch (approx.). I SI Abhijit Singh of Purulia (M) PS received a source information that one person moving suspiciously at Imundi X-ing near Pandey Hotel under Purulia (M) PS with some illegal weapon. I informed I/C Purulia (M) PS regarding the source information and as per his direction myself along with force (i) C/1464 Bhagyadhar Patra & ii) 1410 Suroj Kr. Patra both of Purulia (M) PS left for Imundi X-ing near Pandey Hotel vide Purulia (M) PS C.C No- 1049/2022 dtd 08.04.2022 and GDE No- 380 Dt. 08.04.2022 to work out the source information.

I along with force reached at the PO and as per identification of my source myself along with force stopped the above noted suspected person. I asked his name and address which is noted above. There after disclosing my identity as SI Abhijit Singha of Purulia (M) PS myself and force offered him to search our body in presence of the local witnesses but he denied to do so. When the suspected person refused to search we started searching him and on searching I recovered the above noted fire arms loaded with one live ammunition from his waist. On asking he failed to produce any valid documents and papers in favour of that fire arms and ammunition. He also failed to give satisfactory answer for carrying this arms and ammunition. I seized the arms & ammunition under proper seizer list which was duly signed by the accused person as well as local available witnesses. I unloaded the live ammunition from the said fire arms and seized the arms and ammunition in between 20:45 to 21:15 hrs under proper seizure list. After the seizure I arrested the accused person and issued arrest memo, observing all legal formalities as laid down by Hon'ble Supreme Court regarding the arrest of **Jabir Ansary (25yrs) S/O Jalal Ansary of Vill-Chaluniya, PS- Para, Dist- Purulia**, comes under per view of Indian Arms Act. After that myself along with force with seized articles and arrested accused person returned to PS.

I therefore pray to kindly start a specific case against the above noted accused person under proper section of law and arrange for proper investigation.
