

- 2) That the landed property described in the schedule below was purchased by Cheddi Sao and his three brothers namely Krishnachandra Sao. Ramachandra Sao and Someswar Sao from the rightful owner of the property by virtue of a registered sale deed bearing number 13530 of 1973 and after purchase of the scheduled property said Cheddi Sao and his three brothers are in possession over the scheduled land.
- 3) That During preparation of L.R record the said properties have been recorded in the name of Cheddi Sao and his three brothers in separate khatians. L.R khatian No. 209 of Mouza –Shibdih has been prepared in the name of Cheddi Sao,Said Cheddi Sao sold his share of the schedule property to Smt. Sikha Mondal and Tara Gorain by virtue of a registered sale deed bearing No. 1049 of 2012 and said Smt.Shikha Mondal and Tara Gorain became owner and in possession over the scheduled land. On 12/10/2012,Sri Arun Ghosal i.e husband of the complainant and Siddhartha Ghosal ,brother in law of the complainant purchased the scheduled land from Smt.Shikha Mondal and Tara Gorain by virtue of a registered sale deed bearing no. 3849 of 2012 and thus Siddhartha Ghosal and Arun Ghosal became absoulute owner and possessor of the

scheduled land and they have every right, title interest and possession over the schedule land.

- 4) That In the mean time name of Chhedi Sao has been changed as Chhedi Napit through some dishonest officers of BL& LRO, Purulia -I and some other persons jointly for grabing the schedule property. In the month of November 2021, family member of the complainant came to know that the land of said Chhedi Sao of Mouza-Shibdih being LR Khatian No. 209 was not found and has been recorded in the name of Kanaklata Dube w/o Ananta Dube resident of Village- Shibdih, P.O-Buridih, P.S-Purulia(M), District-Purulia in LR khatian No-1149.
  - 5) Since that day family members of the complainant tried to find out the real conspiracy about the LR record in the name of said Kanaklata Dubey and finally found that said Ananta Dubey i.e. Husband of Kanaklata Dubey changed the name in his Aadhar Card as Chhedi Napit in conspiracy with his wife Kanaklata Dubey, his uncle Sunil Dubey and Lalu Kuiry s/o Debendranath Kuiry of Bhuinyadih, P.O- Shibdih, P.S- Purulia(M), Disctrict-Purulia for the purpose of grabbing and embezzlement of landed property described in the schedule below. In this way said Ananta Dubey represented himself as Chhedi Napit and himself has registered the land in the name of his wife for the purpose of illigally embezzling the schedule land by colluding with his wife Kanaklata Dubey; Sunil Dubey and Lalu Kuiry and also prepared forged government documents and cheated with me.Having came to know the same when family members of the complainant protested against their wrongful act then said Ananta Dubey along with his uncle Sunil Dubey threatened family members of the complainant with dire consequences and also challenged them that they will not rectify as they have well placed connections. Then complainant informed the matter to the Inspector In-Charge.Purulia(M)police station on 07/02/2022. As a result said accused persons also threatened them, that if
