No. WB55A-9346 attached with loaded Sand Trolley and with Seizure list. Memo of Arrest and Inspection Memo in respect of the above noted person before you.

The fact brief is that today (27.04.2022) at 17:15 hrs while I along with force 1) C/611 Jitendra Nath Pathak & 2) C/2734 Susanta Panda both of Purulia (M) PS left the PS for evening & night mobile duty vide Purulia (M) PS CC No 1870/22 and GDE No 1345 Dt. 27.04.2022 in PS area. During my mobile duty, I received a tip off at 17:35 hrs that a suspicious tractor loaded with sand was coming from Namo Pindra Kansai River Ghat towards Upar Pindra village. Subsequently, I along with force proceeded towards Upar Pindra village to work out the tip off. While I along with force arrived at Upar Pindra village Morh under Purulia (M) PS and found that 01 (one) tractor was proceeding towards Upar Pindra village along Namo Pindra to Upar Pindra village road. I along with force intercepted the vehicle (Tractor) bearing No. WB55A-9346 attached with Trolley loaded with Sand and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver of said vehicle disclosed his name noted in the above. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that he (driver) in cahoots with the owner of the vehicle procured the said sand form Namo Pindra Kansai River bed by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor) Bearing No WB55A-9346 attached with Trolley loaded with Sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Chinmoy Sardar (19 yrs) S/O Lt. Kritibas Sardar of Vill- Namo Pindra of Vill- Namo Pindra, PO- Chakirbon, PS- Purulia (M), Dist-Purulia after informing the ground of his arrest and issued Memo of Arrest and Inspection Memo against him. Thereafter, I brought the seized tractor to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against the owner and the driver namely Chinmoy Sardar (19 yrs) S/O Lt. Kritibas Sardar of Vill- Namo Pindra of Vill- Namo Pindra, PO- Chakirbon, PS- Purulia (M), Dist-Purulia of the vehicle as they committed offence u/s 379/411/414 of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-
