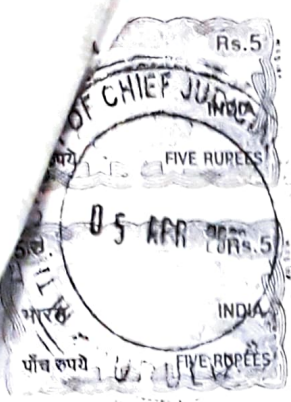

on his person and motor cycle bearing No.WB-56N-6148 has

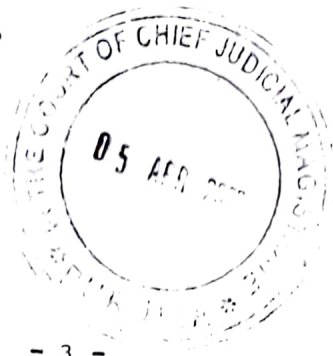
been badly damaged.
